Membership dues are down by about -\$113,254. Some of this is due in part to processing errors related to the e-commerce system. These errors have now been fixed and a portion of the miscalculated funds will be credited back to the account. (Through the end of May, \$48,756 were lost dollars due to this issue). Additionally, some of this is due to timing issues related to transfer of funds to offset complimentary membership fees. These transfers will be made prior to the year-end.

Overall total ALA membership is **58,136** compared to 59,315 in April 2018, a slight decrease of **1.99**% increase. Some of this lost can be attributed to this being a "one-division" conference year instead of two. (During even fiscal years, there is a bump in membership which happens after both the AASL and PLA division national conferences. In odd years there is only the ACRL national conference).

Individual Memberships

Personal Regular membership is down to **29,076** compared to 30,621 last year. (-**5.05**% decrease). We are still experiencing a rapid growth in the Student memberships category which is up from last year at **8,503** compared to 8,134 last year this time. (**4.54**% increase). There were also increases in Retired and Friend member categories. Life, Support Staff, Associate, Trustee, Non-salaried, International, and some categories of continuing memberships are down.

Organizational and Corporate Memberships

Group memberships had growth, (10.07%), while Non-Profits grew (15.52%). Medium, Large Library, and State Library memberships also had growth. Very Small, Small, Very Large Library, Chapter and Corporate memberships are down. International organizational memberships stayed the same.

Four **divisions** had growth: AASL (1.74%), ACRL (1.57%), ASGCLA (31.50%) and UNITED (8.19%). (FAFLRT was integrated into ASCLA to create ASGCLA – Growing from 762 members a year ago to 1,002 members).

Fourteen **Round Tables** had growth: EMIERT (3.12%), FMRT (12.25%), GLBTRT (3.68%), GODORT (0.18%), LearnRT (12.30%), LHRT (0.24%), LIRT (1.91%), LRRT (0.44%), LSSIRT (3.12%), NMRT (3.81%), RMRT (8.36%), SRRT (6.27%), SORT (19.88%), and SustainRT (44.86%). SRRT remains the highest RT membership at 1,916 members. SustainRT had the highest percentage of growth-- growing from 769 members to 1,114 members. The Graphics Novel MIG became the Graphic Novel and Comics Round Table (GNCRT) beginning September 1, 2018, currently has 611 members.

Staffing Update

On June 17, 2019, Melissa Kay Walling, CAE, IOM joined ALA as its new **Director, Membership Development and Customer Service**. Walling is an accomplished association executive with nearly 15 years of experience in serving members, staff and volunteers. She comes to ALA most recently having served as the Vice President, Education & Membership at the *Association Forum of* Chicagoland where she improved operations of external-facing systems to attract and retain members. Most notably, she oversaw the execution of the *Holiday Showcase* —one of the most highly attended events in the industry.

Prior to joining the staff at Association Forum, Walling held positions with the Institute of Real Estate Management and the American Academy of Pediatrics. She also served as a volunteer in the U.S. Peace Corps in Kumasi, Ghana, West Africa. Walling has been recognized by Association TRENDS Young and Aspiring, (2018); Association Forum/USAE Forty under 40 (2013); and American Society of Association Executive's (ASAE's) Next Gen Summit (2013) (Inaugural class).

Walling earned a B.A. in Business Administration from the University of Michigan and is currently pursuing her M.B.A. from the University of Illinois. Walling will be responsible for the overall development, implementation, and measurement of the association's membership strategic initiatives, while overseeing the activities of its fast-paced customer service center and total unit staff of nine.

Virtual Membership Meeting

On May 9, 2019, the Membership Development & Customer Service staff, in conjunction with the staff of the ALA Governance Office and Publishing Department, facilitated the Virtual Membership Meeting (VMM). There were a total number of 853 registrants with 453 final attendees. 100% of the participants felt the content was relevant or very relevant. These

events continue to be very popular with just over 74% of the attendees saying they would attend another VMM in the future.

Spring Activities and Accomplishments

The ALA Membership Development & Customer Service staff are continuing to work with staff from the divisions and round tables to brainstorm ideas related to coordinated marketing efforts, establishing member value propositions and new member onboarding. The Community Engagement Manager within the ALA Member Relations Department has also been working across units to update the Code of Conduct/Community Guidelines within ALA Connect. ITTS staff have worked with the outside e-commerce vendor to correct the problem concerning our e-commerce issues. These errors have now been fixed. They are also assisting with investigating the feasibility of enabling more effective dues renewal automation options.
