2020-2021 Presidential Focus

My 2020-2021 Presidential year will focus on three primary areas: Advocacy, EDI and Membership.

Advocacy - In preparing for these three areas, I began a series of discussions with the Public Policy and Advocacy Office about increasing ALA's advocacy platform with the goal of alignment with building a national network of advocates and policy experts. Plans are also underway for a country-wide library tour, with a focus on underrepresented libraries.

EDI – EDI is a major area of focus. To ensure that all members have access to developing and discussing an EDI consciousness at conference, I am considering an EDI workshop at midwinter and annual conference similar to the workshop provided to Council at the 2019 annual meeting.
