# American Library Association Constitution and Bylaws Committee Report 2018 Midwinter Meeting, Denver, CO

Julius Jefferson, the ALA Executive Board's liaison to the ALA Constitution and Bylaws
Committee met with the committee during its meeting on Saturday, February 10, 2018. He
reviewed the EB's Talking Points documents. The discussion focused on the EB's Organizational
Effectiveness initiative and the role that the Constitution and Bylaws Committee may play as this
initiative develops.

#### 2. Election of Executive Board members

The committee reviewed correspondence initiated by a member of Council regarding eligibility of Council members who have served on Council in past terms but who in the current term have not yet met the eligibility requirements to be a candidate for election to the Executive Board in those years in which the Council's election of EB members includes electing a member of Council to fill an unexpired EB term.

### ALA Constitution: Article VII. Executive Board

**Section 2**. A vacancy in the elected membership of the Executive Board, including a vacancy created by the election of a member to the office of president-elect or treasurer, shall be filled by Executive Board appointment, the person so appointed to serve until the following annual election. ## ALA Bylaws: Article II. Nominations and Elections

**Section 6, ¶3.** [The Council Committee on Committees] "shall nominate annually candidates for three members of the Executive Board for three-year terms, and every third year two members of the Executive Board for three-year terms for election by the Council from among the members of the Council. Candidates shall be nominated from among the members of the Council who are serving by virtue of election to it, as provided in Article IV, Section 2.b., c., d., and e. of the Bylaws, and who will have served at the midwinter meeting and the annual conference immediately preceding their prospective terms as Executive Board Members." The C&B Committee reviewed a document produced by the Governance Office (an appendix to this report) showing the history of elections in which a vacant EB seat had to be filled for a partial term. There have been five instances since 1995 in which a member of Council has been elected to complete an unexpired term:

- 2 due to an unexpired term as a result of election of a member of the EB as Presidentelect (Gorman, Garcia-Febo)
- 1 due to an unexpired term as a result of election of a member of the EB as Treasurer (Bishoff)
- 1 due to a resignation (Norton)
- 1 due to a death (Schlachter)

These are atypical events. The current Bylaws and Constitution provisions address these situations and, as needed, those provisions have been implemented successfully.

### 3. ALA Affiliates

Article X of the ALA Constitution Provides for "National or international organizations having purposes similar to those of the Association or to one or more of the Association's subdivisions may request to become an affiliate of the Association." The ALA Executive Board has approved criteria that the Constitution and Bylaws Committee applies to determine whether or not to recommend that Council approves an application for affiliation. The Constitution and Bylaws Committee is requesting current Affiliates to share their governance documents with the Committee. These documents may be helpful to ALA in the recently initiated comprehensive review of ALA's organizational effectiveness.

4. The Membership Committee consulted with the Constitution and Bylaws Committee about a process for making a possible change to the ALA Bylaws regarding the grace period under which a member who does not renew his/her membership before the member is dropped from membership. The Membership Committee has concluded that present practice and the Bylaws are not in conflict.
