

Coronavirus aka Covid-19


(as of 3/27/2020)

- Virus at pandemic level, verified cases in 159 countries and territories
- Impacting worldwide economy, negatively affecting markets
- Federal Reserve cut interest rates (3/15/20), slashing federal funds rate by 1% to a range of 0-0.25%
- Congress passed \$2 trillion stimulus package, targeting all sectors
- Legislators at all levels working overtime
- US budget deficit for first 5 months of fiscal year up 15% over last year at \$625.0 billion
- US unemployment claims hit 3.3 million in one week, expected to increase
- Airline and travel industries deeply affected
- Unprecedented impact on every aspect of society health, governance, economy

Market and Book Value @ 2-28-20* \$51,845,525




Endowment historical cash flows (as of 2.28.20) Exhibit #3




World Market Performance

Endowment Trustee Activity

- Closely monitoring investment market during pandemic
 - Two update calls with Merrill Lynch advisors, March 18 & 26
 - Receiving investment reports and daily audio updates from ML senior leadership
- · Keeping alert for optimal time to rebalance portfolio as needed
- Working closely with ALA Treasurer and staff to support a healthy financial outcome for ALA
 - Possible transfer of funds to FY20 operating budget
 - Possible change in payout for FY21
- ESG funds now account for 34% of the portfolio; Trustees continue searching for more ESG opportunities
- Responding to member concerns regarding fund management fees and recommendations for Trustee operations
- Continuing to educate members and ourselves
