WOMEN'S FAIR IN SAN FRANCISCO

Women librarians met and exchanged information and ideas at an all day women's fair sponsored by the SRRT Task Force on Women on Sunday, June 29, at the San Francisco YWCA. The morning speaker was Knuti Von Hoven from Women's Action Training in Oakland. She spoke about the specific things groups must do to organize locally and bring about change around a specific issue. First, she stated, we must decide upon our goals. We must decide what we hope to achieve. After setting our goals, we must build a strong organization to go to work in achieving our goals by starting a campaign. She emphasized that we must not stereotype groups of people and decide they wouldn't be interested in our campaign. Once we have built our organization, we must see that our campaign pays for itself, respects the time and money of those working on it and strengthens the organization. The group then broke into small discussion groups by geographical area and tried to use the methodology learned in real situations.

During and after lunch many women toured the exhibits of women's presses and women's groups from the Bay Area. The afternoon program featured librarians talking about their experiences combining feminism in their work as well as their personal lives. Panelists included Sherrill Cheda and Phyllis Yaffe of Emergency Librarian, Ginnie Cooper Bruxvoort and Janet Freedwoman. The fair ended with a dance featuring a women's rock group.

ALA MEETINGS

Dora Bilbartz (Univ. of California at Davis) chaired a program on the acquisition of feminist materials for libraries. Ms. Bilbartz reported on a separate collection on women at the University of California at Davis Library. Among the topics discussed were the collection of library school bibliographies on women and how to buy pamphlet material.

On Tuesday evening of ALA feminist librarians met to discuss forming a group outside ALA. Helen Josephine reported on the Women's Fair, Carole Leita reported on having groups both within and outside of ALA and Pat Schuman discussed the caucus idea and supported the development of a network of women. The group after considerable

discussion voted to form a group known as Women Library Workers which would work on issues outside ALA while the SRRT Task Force on Women would continue to address itself to ALA related issues. A second meeting was held on Thursday noon. Carole Leita agreed to send out a questionnaire to all interested members to get opinions on organizational matters. Regional groups were also begun. A business meeting of the Task Force on Women was held on Thursday, July 3. The meeting was chaired by Liz Futas. TF coordinator.

- 1) Liz Dickinson reported that 110-125 people regularly use the Task Force job roster newsletter. She noted a lack of public and special library listings and said that most of the listings currently come from academic libraries. Three women from Philadelphia will do the job roster newsletter next year. They are Jeannette Neal (2224 Green St., Philadelphia, Pa. 19130), Holly Lewis and Meg Randall.
- 2) Helen Josephine reported that the Women's Fair had broken even. They received \$250 from SRRT and \$300 from last year's Preconference. 116 people registered for the morning workshop and 250-300 people attended the afternoon session. 45 groups exhibited.
- 3) Carole Leita reported on the formation of Women Library Workers. They have a membership list of 125 people and a budget of \$700. They will send out questionnaires to members in six weeks to two months.
- 4) Liz Futas reported on correspondance with ACRL and the Council of Library Resources asking for a similar program for women to their internship for black librarians.
- 5) Linda Crowe was elected the new Task Force coordinator. Her address is 1356 Scott Ave., Winetka, Ill. 60093.
- 6) There will be a women's program on the Sunday of ALA (1976) in Chicago. Send suggestions for this program to Linda Crowe.
- 7) A strategy session for ALA Councilors at Midwinter will be sponsored by the Task Force.
- 8) Tee shirts and buttons for the Chicago conference will be produced.

RESOLUTION ON SEXIST TERMINOLOGY

The Task Force on Women submitted a resolution to ALA membership requiring guidelines for ALA staff for future ALA publications and for review of all advertising copy to eliminate sexist terminology. This resolution which was approved was submitted as a result of sexist terminology used in the ALA conference program and in an ALA National Library Week ad.

NEW YORK-NEW JERSEY LIBRARIANS/LIBRARY WORKERS FEMINIST CAUCUS

A New York-New Jersey Librarians/Library Workers Feminist Caucus was formed on April 7. 1975 in New York City. The purpose of this organization will be "to further the feminist cause within and without the library profession". The organizing members present voted to be a sponsoring organization of the Greater New York Feminist Credit Union now being formed. WLW PROTESTS DOWNGRADING OF CETA EMPLOYEES

The Bay Area Chapter of Women Library workers has protested the decision of the San Francisco Board of Supervisors to downgrade all CETA positions paying more than \$10,000 annually. The San Francisco Public Library is currently receiving from the CETA program \$450,000 per year of professional library services at a cost to the city of only \$39,649 per year. The Board's attempt to save this comparatively small amount of money jeopardizes the professional status of these CETA employees and threatens to curtail many valuable services to the community...(from a 8/22/75 news release)

DISCRIMINATION AT FRIVATE CLUBS IN NEW YORK

The New York Times (6/3/75) reported that Mrs. Eleanor Holmes Norton, New York City's Human Rights Commissioner, has called for an end to discrimination by private clubs in a 72 page report on sex, race and religious bias by clubs. The article stated: "...a librarian, acknowledged as an expert in the field of rare books, testified that she could not join the Grolier Club, the prestige association in the profession. Membership not only indicates expertise, the report noted, but also provides access to major world libraries and to professional information not otherwise available. In addition, recruitment for the 'cream' of librarian opportunities is from the club membership, it said." The report stated "that employers often rely on club membership..." and that "ineligibility for club membership sometimes is cited as a reason women cannot assume executive positions."

NIH WOMEN SUE

In 1971 Rosalind B. Marimont filed a suit against National Institutes of Health after working for them for 11 years without a promotion. Mrs. Marimont's case has formed the basis for a suit asking the court to enjoin NIH from discriminating against women and to require the agency to establish a plan for ending alleged sex discrimination. The suit also requests back pay for all NIH women employees who allegedly have been discriminated against in pay and promotions. Libraries at NIH include the National Library of Medicine and the NIH Library. A favorable decision on this case could benefit all federal women employees including other federal librarians.
