# AB 995: What you can do to make an impact!

## What is AB 995?

<u>AB 995</u> is a policy which expands access to Transitional Housing Program Plus (THP-Plus) to foster youth starting at age 16, instead of 18. In addition to providing housing for two years once youth emancipate from foster care, THP-Plus includes supportive services such as job readiness training, educational support, and life skills training.
