I assumed the position of member editor on December 1, 2019. December through February I

shadowed Linda Braun, acting editor. She completed the Fall 2019 and Winter 2019 issues of

YALS. During this time I began meeting with the EAB on a bi-weekly basis to begin planning

the spring, summer, and fall 2020 issues of YALS. We worked to develop the themes for the

2020 publication cycle, focusing on issues that are current to the field, reflect the Teen Services

Competencies, and YALSA's mission and vision.

Starting in the 2018-2019 publishing cycle the EAB has made it a priority to try to balance

articles from both public and school library perspectives. YALS has continued to make this a

priority while also seeking articles that are relevant to the mission of the journal by other

professions (social work, youth organizations, etc.). The EAB also made it a priority to increase

the diversity of authors. Although we are attempting to accomplish this goal through outreach

and the networks of the advisory board, it has been a bit of a struggle. So, the EAB decided to

issue open calls for authors starting with the Fall 2020 issue.

The future issue themes are listed below:

Spring 2020: Teen-Driven Services

Summer 2020: Middle School

Fall 2020: Trauma-Informed Services

According to the last report, YALS has been digital since Summer of 2018, and the feedback has

been positive. However, there have been suggestions concerning some issues with the articles.

In order to address these issues a proposal was made in Document #25 as noted below:

This proposal recommends that YALS adopt a different digital format in the form of an email

publication, much like what ACRL uses. This format would make the digital articles easy to

access and easy to share, helping to get the information into our members hands and support

them using it to advocate for teen services within their organizations. This would require the

design of a template by the YALS Editor in conjunction with the communication manager. It

would also require YALSA to determine where the articles can be uploaded as PDFs so they can

be accessed by members. This could need to be done either through the website or the YALSAblog. It would also require the editor to create a page for each issue on the YALSAblog and link it to the archive page for YALS. The creation of the new asset templates could be a project completed by the outgoing YALS editor so that the incoming editor could start using the new format immediately. I am not sure that this issue has been rectified as there is no new platform.

As I complete my tenure as the YALS member editor, my goals are to have the journal back on production schedule and to work on completing the new digital platform, as stated above, if necessary.
